

# Top Five Reasons Florida Needs the “Only U.S. Citizens Can Vote” Bill

Current Florida law has loopholes that allow illegal voters to cancel U. S. citizen votes. Rep. Berny Jacques, Rep. Chase Tramont, and Senator Ileana Garcia’s HB831/SB1330 2025 session bills close the loopholes!

## 1) Non-Citizens or Fictitious Persons Anywhere in the World Can be Registered to Vote via the Federal Postcard Application (FPCA)

- The FPCA allows anyone worldwide to register without citizenship verification.
- It is available in many languages.
- In 2022, Florida was home to 7% of the U. S. population but had 25% of the 737,438 uniformed and overseas (UOCAVA) registered voters across all states.
- In 2024, the DNC had a major initiative to register millions more UOCAVA voters.

## 2) Over 2M Voting Age Non-Citizens in Florida Can Register to Vote

- Florida Department of Motor Vehicles (DMV) processed 4.6M transactions with non-citizens for IDs from 2020-2024.
- Non-citizens receive driver’s licenses & state IDs with minimal documentation.
- Non-citizens receive SNAP (food stamps) and have been solicited to register to vote by the Florida Department of Children and Families (DCF).
- Anyone who registers to vote with their Social Security number or “No ID” bypass citizenship verification.

## 3) No Systematic Removal of Non-Citizens from Voter Rolls

- Non-citizens removed from Miami-Dade voter rolls were registered for an average of 9 years and many voted in multiple elections.
- Supervisors of Elections are not required to report non-citizen removals to law enforcement. Only a small percentage non-citizens who register to vote or vote in FL are prosecuted.

## 4) Other Illegal Voters Remain on Florida Rolls

- Deceased individuals, fictitious persons, and out-of-state movers are voting.

## 5) Florida Has Databases That Can Identify Illegal Voters but They are Underutilized by Election Officials

- DMV, DCF, and other state databases track citizenship status and out-of-state moves but current law does not mandate their use to clean voter rolls.
